### Hunting Rules for Burban Creek Planation Reserve:

*\*\*The following rules were voted and approved by the Board\*\**

#### Basic Practices and Guidelines:

1. Members are allowed to bring (1) guest only per day for deer and bear hunting and (2) guests per day for turkey, migratory bird, and small game hunting. Guest must be accompanied by a member on the Reserve. Youth hunters under the age of 16, must be accompanied by an adult at all times during the hunt. Members and guest must sign in "in person" and guest must sign the Burban Creek Waiver.
2. No signing in before 5:00AM of the same hunt day. At the end of the hunt, all name tags must be removed from the map.
3. Club stand/personal stands selection is "First Come First" basis. Personal stands are subjected for use by other members or guest.
4. During deer, bear, and hog season all hunters, including small game hunters, must wear International Orange. Hunting for dove, turkey, ducks, geese and other migration birds are exempt from this requirement.
5. No member or guest may possess, consume or be under the influence of intoxicants, including beer, wine, liquor or drugs.
6. All hunters must be aware of dangers and safety concerns beyond intended target. Avoid overcrowding areas.
7. Burban Creek Plantation Reserve will be closed during deer and turkey season. Only hunters who are signed in on the map can be allowed on the Reserve. Absolutely no joy riding or hiking. Please be courteous to other hunters and avoid the area they are hunting.
8. Large game, Migratory bird and Small game seasons to follow SCDNR schedule for private land.
9. No night time predator hunting during turkey, deer or bear seasons.
10. Turkey hunting dates will be selected during hunt draw, if you are not able to hunt your selected date, it is encouraged to post the date for other members to hunt. Turkey hunting will conclude at 1:00pm on your selected date.
11. The reserve will be divided into 3 hunt zones for turkey season.
12. No ATV traffic is permitted on the reserve during turkey season.

#### Harvest Guidelines:

1. All harvested animals must have photo proof submitted to the Board member within 24 hours via email or text message and recorded harvest book in barn.
2. A total limit of (2) eligible buck are allowed to be harvested per property owner and/or guest from the Reserve.
3. Antlered deer must have at least 4 identifiable points on one side. (For example: A 7 point is allowed, as long as 4 identified points are present on one side.). (\$250 fine will be assessed to the owner if a member or his guest breaks the hunting rule, at the discretion of the Board). Any deer taken rather eligible or not will count against your limit.
4. No Doe will be harvested from the Reserve.
5. No bear party dog hunting is allowed on the Reserve.

6. A total of (1) eligible turkey is allowed to be harvested per property owner and/or guest from the Reserve.
7. Migratory bird and dove hunting limits follow SCDNR regulations.
8. The rules above are for the Reserve only. Members to follow SCDNR Regulations on personal lot.

**Participation in any hunting activity on the Reserve agrees acceptance and compliance to the above stated rules.**

**Any violations to the above rules will be addressed by the Burban Creek Board and may result in a penalty or fine of up to \$250.**
